- Making payment with check, cash or credit card during business hours in the Treasurer's Office (8:30am to 4:30pm - Monday through Friday except holidays), please remember to bring a payment coupon.
- Dropping a check with coupon in the property tax drop box, which is available 24 hours a day. The drop box is located behind Building "A" at the Kane County Government Center in Geneva, IL. Check and coupon must be in an envelope.
- Credit card or E-check over the Internet. Please
